RESERVATION:

Reservation for SEBC, ST, SC, PH, Sports Man, Ex-Service Man is applicable under concerned rules.

AGE:

The candidates must have completed **18 years** of age as on **1.7.2011** and the upper age limit as prescribed by the Govt.

MODE OF SELECTION:

The selection will be made strictly basing on the marks secured by the candidates in the qualifying Examination prescribed for the post and as per the guidelines laid down by Govt.

GENERAL CONDITION:

1. The engagement on contractual basis is purely temporary and may be terminated at any time without any notice and without assigning any reasons thereof. The elected candidates will have to sign an agreement prescribed by Finance Department for the purpose.
2. The candidates shall have to submit an undertaking to the effect that they will not claim any Govt. Post/Regular appointment in future as a matter or right. They will also undertake that they will not claim any financial benefit other than the **monthly** consolidated amount which they will receive.

3. The candidates will not claim for any Govt. accommodation and they have to arrange for their own accommodation.
4. The candidates appointed on contractual basis will not claim for inter Medical College transfer.
5. The applicants have to apply to the Superintendent, VSS Medical College Hospital, Burla, 768017, Dist: Sambalpur by Regd. Post/Speed Post only.
6. The vacancy position mentioned may vary in future.
