An advertisement vide this office Notification No.398/MCH dt.12.1.2011 for engagement of 184 nos of Contractual Staff Nurses was published in the Daily New paper the "Dharitry" dt.22.1.2011, Subsequently, 08 nos of contractual Staff Nurses have arisen, the total vacancy ^{do the regular cadre. one} becomes 192 which were considered to be filledup. In total 332 nos of applications were received on or before the due date i.e.28.2.2011 and after scrutiny 51 nos of applications were rejected due to various reasons leaving behind a balance of 281 valid applications which were placed before the committee along with common merit list prepared therefore.
